Please be advised that NOVAPOL, SCLAIR and SURPASS polyethylene resins and their components, as supplied by NOVA Chemicals Corporation, do not contain any reproductive toxins or carcinogenic substances, per the state listing of chemicals, as amended on May 25, 2018, that would require a warning under the California Safe Drinking Water and Toxic Enforcement Act of 1986 (Proposition 65).
